Bridge of Hope National offers a variety of resources to help Christians end and prevent homelessness among single women and children in their community. In fiscal year 2015-16, the Bridge of Hope network served 272 women and children. Also in 2015-16, 706 mentors volunteered their time in friendship with homeless families, completing 4.5 hours of advance training and 2 hours of ongoing monthly training. In fiscal year 2015-16, 3 new locations joined the Bridge of Hope network in Wayne County (MI), Hickory (NC) and Browns Mills (NJ). There are now 22 Bridge of Hope locations in 13 states and Canada.
