Bridge of Hope National offers a variety of resources to help Christians end and prevent homelessness among single women and children in their community. In fiscal year 2014-15, the Bridge of Hope network served 283 women and children (an increase of 12%) with a goal of serving 336 in 2015-16. Also in 2014-15, 814 mentors volunteered their time in friendship with homeless families, completing 4.5 hours of advance training and 2 hours of ongoing monthly training. In fiscal year 2014-15, 3 new locations joined the Bridge of Hope network in Dana Point (CA), Denver (CO), and Calgary (AB - Canada). There are now 23 Bridge of Hope locations in 13 states and Canada.
