

A CHURCH-BASED APPROACH
TO ENDING FAMILY HOMELESSNESS

WHAT IS A PLANNED GIFT?

A planned gift is a gift that is made with more planning and discernment than a typical annual operating fund contribution. Examples of planned gifts include bequests, charitable gift annuities, charitable remainder trusts, and charitable lead trusts.



HOW DO I MAKE PLANNED GIFTS?

- Talk with Bridge of Hope National about what legacy you would like to leave to this ministry. Planned gifts can be restricted or unrestricted for specific projects, designated for general operations or to the Bridge for Tomorrow Endowment. The board of directors of Bridge of Hope National has a policy that any planned gift/bequest that is unrestricted will be allocated with the first \$5000 to general operations and the remaining funds directed to the Bridge for Tomorrow Endowment.
- Contact your financial planner/advisor or attorney to discuss the amount of the gift that would work to maximize your tax and financial benefits.

BRIDGE OF HOPE NATIONAL PLANNED GIVING OPTIONS

- Bequest: Designate through your will that a
 portion of your estate go to Bridge of Hope
 National. You may be able to reduce estate or
 inheritance taxes since charitable bequests are
 deductible from your estate. Suggested wording
 for your bequest is available upon request.
- Charitable Gift Annuities: Receive a guaranteed income payment for life. Receive a tax savings, plus part of your income may be tax free.
- Charitable Remainder Unitrust: You can fund a unitrust through assets or cash. Receive lifetime income, get an immediate tax deduction and avoid capital gains tax, and minimize estate taxes.
- Charitable Funds: You donate cash or other assets to be placed in an irrevocable fund. It is a gift given to be distributed to Bridge of Hope National and/or other charities as you determine.

WHAT CAN BE GIFTED?

- Cash
- Appreciated assets such as real estate, stocks, and retirement assets
- Other gifts including farm commodities
- Life insurance
- Retirement Funds (list Bridge of Hope National as a secondary beneficiary after your spouse or as a primary beneficiary at a certain percentage along with your other beneficiaries)
