In fiscal year 2017-18, the Bridge of Hope network served 209 women and children. Additionally, over 450 neighboring volunteers from Christian faith communities volunteered their time in providing tangible supports and friendship with homeless families, completing 5 hours of advance training and 2 hours of ongoing quarterly training. Outcome highlights for 2017-18 programming include: 84% of families exiting Bridge of Hope had safe and stable housing & 87% of families exiting Bridge of Hope were employed. 90%
