Leaders of Hope is an annual giving society based on giving \$1,000+ for Bridge of Hope National's fiscal year, April 1 - March 31.

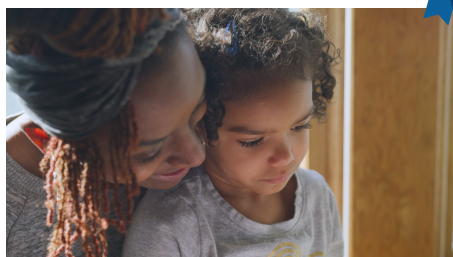
