Bridge of Hope National offers a variety of resources to engage Christian faith communities in ending and preventing homelessness for families (primarily single women and children) through the training of Neighboring Volunteers, professional case management and rental assistance funds. This past year has been a challenging year with coronavirus and the pandemic. We are so grateful that in these difficult days, we have been able to serve 27% more families facing homelessness. Six new Bridge of Hope locations have joined the Bridge of Hope network this fiscal year, for a total of 25 locations in 13 states.

Our data shows strong program performance this past year, even in the midst of a global pandemic.

- 314 adults and children served, which is a 27% increase over the previous year.

- 35% decrease in the number of days it took to house the average family (from 49 days to 32 days this fiscal year).

- 93% of exiting families live in safe and sustainable housing

- 450 Neighboring Volunteers from churches, which is a 13% increase over last year.

In September 2019, Bridge of Hope National also began directly operating the Bridge of Hope affiliates in the two founding counties: Lancaster, PA and Chester County, PA. Community boards now oversee and support each county and Edith Yoder, CEO, chairs each board. Both counties are governed
