Bridge of Hope National offers a variety of resources to engage Christian faith communities in ending and preventing homelessness for families

(primarily single women and children) through the training of Neighboring Volunteers, professional case management and rental assistance funds.

Bridge of Hope National also provides direct services in two counties:

Lancaster County and Chester County, PA. The Bridge of Hope network is comprised of 21 locations in 13 states.

Our data shows strong program performance from this past year:

- 367 adults and children served.
- 653 Neighboring Volunteers from churches.
- 54 days, on average, to find housing for families (despite a nation-wide housing crisis).
- 87% of exiting families live in safe and sustainable housing.
